- Must be able to attend mandatory Leadership Retreat on October 14 & 15, 2025 (in Detroit Lakes MN)

### **FM REALTORS® DIRECTOR DUTIES:**

# Director candidates must have served on at least one committee for a minimum of any one year prior to taking office.

- Attend all Directors and Special Meetings
- Know management functions and organization's direction
- Serve as Director in Charge of Committees assigned by the President and fulfill any duties assigned by the President
- Directors are strongly encouraged to attend State Meetings
- Must be able to attend mandatory Leadership Retreat on October 14 & 15, 2025 (in Detroit Lakes, MN)

### NDAR & MNR DIRECTOR DUTIES:

# Director candidates must have served on at least one committee for a minimum of any one year prior to taking office.

- Attends all State Association Board of Director, and other meetings as required by the state association
- Encouraged to attend State Convention
- Relays relevant information back to local Board of Directors, as necessary
- Fulfill any duties assigned by FMR President
- State Directors are ex-officio, non-voting members of the FMR Board of Directors
